You must email MSTA of your acceptance of the rental membership to [membership@mcleanswimandtennis.org](mailto:membership@mcleanswimandtennis.org) within five (5) days of your notification. MSTA must receive your payment of \$900.00 (\$800.00 dues and \$100.00 special assessment for capital improvements) for a rental membership within five (5) days thereafter or the rental space will be forfeited to the next waiting applicant.

I understand that only the applicants, their unmarried, dependent children, and permanent occupants of the address listed below, for example an au pair, will be able to use the pool and facilities without payment of guest fees. Babysitters and live-out nannies will be allowed entry at no charge when they accompany any of the below-listed children for the duration of their time at the club. Guest passes may be purchased for \$5.00 each.

I also understand that renewal of a rental membership is not guaranteed in subsequent years. Renters do not have membership equity in MSTA. The application fee is due each year applicant applies for rental.
